

Rules:

- This event is designed to prepare both the handler and dog for actual trialing. If you have been through agility classes, but are not quite ready to trial, this is an excellent chance for you to prepare for competition. Runs can be timed and judged. You will be given a maximum of 3 minutes of floor time for each of your runs. No awards or placements will be given. This is not for competition, but for fun, experience, & practice. Treats & toys in the ring are encouraged, and praising your dog is mandatory. Dogs must be able to do all pieces of equipment safely and must be under control both in and out of the ring. Harsh corrections, either physical or verbal will not be tolerated.
- Dogs cannot run on a leash, and only flat buckle collars (no tags) are allowed in the ring.
- Jump height is at your discretion and dogs must be at least one year of age to participate.
- The organizing group may refuse entry for any reason. There will be no refunds after the closing date of 3/6/09.
- There will be homemade soup and desserts available for lunch at a nominal charge.

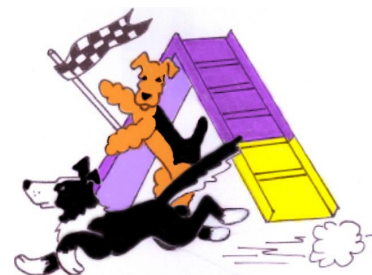

The undersigned is voluntarily engaging in dog agility as a recreational activity with the knowledge of the risks of injury, death & property damage that may result from participation in dog agility.
2. **Release of Liability**  
The undersigned releases Ready To Run Dog Training, LLC from all liability to the undersigned, the "undersigned" representatives, guardians, successors, assigns, heirs, & next of kin for all liability, claims, damage, or demands for personal injury, death, or property damage, to the undersigned or the undersigned's dog or dogs, arising from or related to this agreement. This release includes, without limitation, any personal injury, death, or property damage caused by the active or passive negligence of Ready To Run Dog Training, LLC. The undersigned bears sole responsibility for any loss.
